

AMENDMENT TO CHARTER SCHOOL CONTRACT

THIS AMENDMENT TO CHARTER SCHOOL CONTRACT (this “**Amendment**”) is made and entered into as of October 25, 2019 (the “**Effective Date**”), by and among the BOARD OF GOVERNORS FOR UNIVERSITY OF CENTRAL MISSOURI (“**UCM**”), and HOGAN PREPARATORY ACADEMY, a Missouri non-profit corporation (“**Charter School**”). As used in this Amendment, the term “**Parties**” shall mean each of UCM and Charter School, and individually each is referred to as a “**Party**”.

RECITALS

WHEREAS, UCM and Charter School are the parties to that certain Charter School Contract dated as of June 24, 2010 and as previously amended (the “**Charter Contract**”);

WHEREAS, the Missouri General Assembly has amended the state statutes governing Charter Schools, including, Mo. Rev. Stat. § 160.400.16, *et. seq.*;

WHEREAS, the Parties wish to amend the Charter Contract as specified herein to comply with the revisions to the Missouri Statutes.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

1. As of the Effective Date, the Charter Contract is hereby amended as follows:

(a) **ARTICLE III-TERM OF THE CHARTER SCHOOL CONTRACT**

Section 3.1. The term of this Charter School Contract shall be extended one year from the 1st day of July, 2020 to the 30th day of June, 2021, unless terminated prior to that time in accordance with the provisions of Article V of the Charter Contract.

2. Except as provided in this Amendment, all of the terms and conditions as set forth in the Charter Contract and previous Amendments shall remain in full force and effect. From and after the Effective Date, all references in the Charter Contract to the term “Charter School Contract” or “Agreement” shall mean the Charter Contract as amended by this Amendment.

3. This Amendment may be executed in one or more counterparts and the signature pages combined to constitute one document. A signature of a Party to this Amendment sent by facsimile, .pdf file, or other electronic transmission shall have the same force and effect as an original signature of such Party.
